### **ORDINANCE NO. 2026-4**

#### **AN ORDINANCE REPEALING ORDINANCE NO. 2026-2 ANNEXING CERTAIN REAL PROPERTY INTO MAYFIELD TOWN, UTAH**

WHEREAS, Mayfield Town, a Utah municipal corporation ("Town"), previously adopted Ordinance No. 2026-2 annexing certain real property into the municipal boundaries of the Town; and

WHEREAS, Ordinance No. 2026-2 was adopted on February 11, 2026, following the required petition, notice, and public hearing process in accordance with Utah Code Title 10, Chapter 2, Part 8; and

WHEREAS, Section 7 of Ordinance No. 2026-2 provides that the ordinance shall take effect only upon issuance of a Certificate of Annexation by the Lieutenant Governor of the State of Utah; and

WHEREAS, the Certificate of Annexation has not been issued, and the annexation has not become effective; and

WHEREAS, the Mayfield Town Council finds it is in the best interest of the Town to repeal Ordinance No. 2026-2 and withdraw the proposed annexation;

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF MAYFIELD TOWN, UTAH, AS FOLLOWS:

#### **Section 1. Repeal of Ordinance No. 2026-2**

Ordinance No. 2026-2, entitled "An Ordinance Annexing Certain Real Property into Mayfield Town, Utah, and Extending the Town Boundaries," is hereby repealed in its entirety.

#### **Section 2. Withdrawal of Annexation**

The proposed annexation of the real property described in Ordinance No. 2026-2 is hereby withdrawn and shall have no force or effect.

#### **Section 3. Filing and Recording**

The Town Recorder is directed that no filing of annexation documents with the Office of the Lieutenant Governor or recording with the Sanpete County Recorder shall occur for Ordinance No. 2026-2.

**Section 4. Effective Date**

This ordinance shall take effect immediately upon adoption.
