ANNEXATION BOUNDARY DESCRIPTION

A PARCEL OF LAND LOCATED IN THE SOUTHWEST 1/4 OF SECTION 32, TOWNSHIP 19 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN, IN SANPETE COUNTY, UTAH (BASIS OF BEARINGS FOR THE FOLLOWING BEING N00°00'35"W BETWEEN THE WEST 1/4 CORNER AND NORTHWEST CORNER OF SAID SECTION 32), SAID PARCEL BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

BEGINNING THE INTERSECTION OF THE QUARTER SECTION LINE AND THE SOUTH LINE OF THE RECORDED DESCRIPTION FOR PARCEL S-10554, SAID POINT BEING S00°04'21"E 132.00 FEET ALONG THE QUARTER SECTION LINE (2 CHAINS SOUTH BY RECORD) FROM THE CENTER OF SECTION 32, TOWNSHIP 19 SOUTH, RANGE 2 EAST, SALT LAKE BASE AND MERIDIAN; THENCE ALONG SAID QUARTER SECTION LINE AND THE EAST LINE OF PARCELS S-10546X1, AND S-10546X, S00°04'21"E 233.16 FEET, MORE OR LESS TO AN EXISTING FENCE LINE AND THE NORTH LINE OF 100 SOUTH STREET; THENCE ALONG SAID FENCE LINE AND NORTH LINE OF 100 SOUTH STREET, AND ALONG THE SOUTH LINE OF PARCELS S-10546X, AND S-10546X3, S89°36'52"W 340.17 FEET; THENCE ALONG THE WEST LINE OF PARCEL S-10546X3, N00°47'39"E 241.35 FEET, MORE OR LESS TO SOUTH LINE OF THE RECORDED DESCRIPTION FOR PARCEL S-10554; THENCE ALONG SAID RECORD DESCRIPTION LINE, S89°00'00"E 336.57 FEET, MORE OR LESS TO THE POINT OF BEGINNING.
